

Potential offerors have raised the following question regarding the request for proposal for the Energy & Water IQC. To assure that all offerors are treated fairly, the question is answered herein so that all offerors receive the same information. In general questions are presented as submitted by potential offerors. However, some questions may have been edited or paraphrased by USAID. *Answer: Offerors are reminded of RFP Section L.11, Late Submissions, and advised that proposals must be received by USAID by the time and date stated in the RFP.
